Description

International Long Distance Service is a component of Local Interconnection Service (LIS) described in the Company's Tariffs or Price Lists on file with the appropriate state commissions or in state-specific service guides.

Terms and Conditions

"Company" means an affiliate of Comcast that is a Competitive Local Exchange Carrier (CLEC) certificated by the applicable regulatory authority to offer telecommunications services.

"Customer" means the provider of retail interconnected VoIP service, as defined in 47 C.F.R. § 9.3, that purchases LIS from the Company in order to serve its own customers, which are the Subscribers to the interconnected VoIP service provided by the Customer.

"Subscriber" means the interconnected VoIP end-user customer of the Customer

International Calling is offered subject to the following conditions:

Customer must choose the Company as their Primary Carrier for Local Exchange, Intrastate Toll and Interstate Long Distance.

The rates included in this schedule are limited to direct-dialed station-to-station international calls that are made from the home (for residential service), or business (for business service) of an end-user subscriber of a Comcast LIS Customer. (Calls requiring the assistance of an operator are not included in this schedule of rates.)

The usage rates shown are per-minute, per country, 24 hours a day, seven days a week. The duration of each call is recorded in whole minutes, with partial minutes rounded up to the next whole minute (for example, a 45-second call will be billed as a one-minute call).

Calls placed to mobile (cellular) subscribers are subject to the rates listed under the heading "Mobile Rate Per Minute".

Service is offered subject to the continuing availability of billing, facility and technical resources.

Local, State and/or Federal taxes may apply. The Company reserves the right to pass on taxes or fees imposed on the Company by any taxing authority. The Company may also pass on surcharges imposed by other Carriers based on the Customer's usage.

Service will be discontinued upon notification of a change in the Customer's Primary Carrier or upon disconnection of the associated LIS.
