#### 1. APPLICATION OF TARIFF

#### 1.1. GENERAL

This Tariff applies to the furnishing of Comcast Service, defined herein, by Comcast Phone of Illinois, LLC (hereinafter referred to as "Comcast" or as the "Company"). Comcast Service is furnished for the use of end users in placing and/or receiving telephone calls within the state of Illinois. Services, features, and functions will be provided where facilities, including but not limited to billing and technical capabilities, are available.

The provision of Comcast Service is subject to existing regulations and terms and conditions specified in this Tariff and the Company's service guides, and may be revised, added to, or supplemented by superseding issues.

#### Access Line

An arrangement which connects the customer's location to the Company's designated point of presence or network switching center.

#### Account

The customer who has agreed, verbally or by signature, to honor the terms of service established by the Company. An account may have more than one access line billed to the same customer address.

#### Authorized User

A person, firm or corporation, or any other entity authorized by the customer to communicate utilizing the Company's services.

#### **Automatic Location Identification (ALI)**

An E911 feature that provides the name or address or both associated with the calling party's telephone number (identified by ANI as defined below) to the PSAP for display. Additional telephones with the same number as the calling party's (e.g., secondary locations, off-premise extensions) are generally identified with the address of the telephone number at the main location.

# Automatic Number Identification (ANI)

An E911 feature that provides for the telephone number of the calling party to be forwarded to the PSAP.

#### Basic Local Exchange Service

Basic local exchange service means residential and business lines used for local exchange telecommunications service as defined in Section 13-204 of the Public Utilities Act Excluding: (A) services that employ advanced telecommunications capability as defined in Section 706(c)(1) of the Telecommunications Act of 1996; (B) vertical services; (C) company official lines; and (D) records work only.

# Basic Local Exchange Service Installation

Basic local exchange service installation shall include all installation and move orders of residential lines, including orders for additional lines, and shall exclude orders for the following: (A) services that employ advanced telecommunications capability as defined in Section 706(c)(1) of the Telecommunications Act of 1996; (B) vertical services; (C) payphones; (D) company official lines; (E) records work only; and (F) orders impacted by the customer for the following reasons: (i) hold for payment (ii) customer will advise (iii) customer requested later due date (iv) no access.

#### **Broadband Service**

Broadband Service provides the customer with an access line and usage within a Local Calling Area for the transmission of two-way interactive switched voice or data communications.

### **Company**

Whenever used in this Tariff, "Company", "Comcast" or "Comcast Phone" refers to Comcast Phone of Illinois, LLC, d/b/a Comcast Digital Phone unless otherwise specified.

#### Customer

The person or legal entity that subscribes to service under this Tariff and is responsible for payment of tariffed charges for services furnished to the customer.

#### **Customer Premises**

The customer premises is all space in the same building occupied by a customer and all space occupied by the same customer in different buildings on contiguous property.

#### Exchange Area

The geographic territory established by the Company and approved by the Commission for the provision of local telecommunications services.

#### Local Exchange Service

A service which permits calling to stations in the customer's local service area.

# Local Service Area

A local service area is the region, comprised of one or more exchange areas, within which a customer can call another station at the rates and charges as specified in this Tariff.

"Public Utility Commission" or "Commission"

# Residential Service

Service is classified and charged for as Residential Service where the primary use of the service is of a domestic nature and where the business use, if any, is merely incidental.
