"You" and "Your" mean current or potential customers.

"Company" means Comcast Phone, LLC and any subsidiaries or affiliates providing service under this Service Guide.

### 1. To be subject to this surcharge, you must:

 Access an operator by dialing the appropriate operator code to complete an Operator Assistance or Person-to-Person international call.

### 2. The Operator Dialed Surcharge applies to the following types of calls:

- Operator Assistance and Person-to-Person when the caller elects to dial the appropriate code (e.g. 0, 00) and requires prompting by the operator system to dial or requests the Operator to dial the called telephone number.
- Calls to international countries where direct dialing equipment is not available.
- When the calling party cannot make the call due to trouble on the telecommunications network and the caller elects to have the call completed by the Operator.
- Made on 0- basis in which an Operator places the call after a successfully completed Busy Line Verification and Busy Line Interruption process takes place.

## 3. This charge does not apply to the following types of calls:

■ Collect calls to international countries/areas (including Mexico and Canada).

- Billing Availability:
