1.3. APPLICATION

This Tariff applies to the furnishing of Interexchange Service, defined herein, by Comcast Phone of Virginia, LLC (hereinafter referred to as the "Company".) Interexchange Service is furnished for the use of end users in placing and/or receiving long distance telephone calls within the Commonwealth of Virginia.

The provision of Interexchange Service is subject to existing regulations and terms and conditions specified in this Tariff and the Company's other Tariffs and Service Guides, and may be revised, added to, or supplemented by superseding issues.

1. APPLICATION OF TARIFF

1.6. DEFINITIONS

Broadband Service

Broadband Service provides intrastate long distance calling provided in conjunction with Broadband Local Service, as set forth in Comcast Phone of Virginia, LLC, Tariff V.S.C.C. No. 1.

Business Service

Service is classified and charged for as Business Service where the primary use of the service is of a business, professional, or occupational nature, or where a business directory listing is furnished.

Company

Comcast Phone of Virginia, LLC

Customer

The person, firm or corporation which purchases service and is responsible for the payment of charges and compliance with the Company's regulations.

Customer Premises

The customer premises is all space in the same building occupied by a customer and all space occupied by the same customer in different buildings on contiguous property.

LATA

A Local Access and Transport Area established pursuant to the Modification of Final Judgment entered by the United States District Court for the District of Columbia in Civil Action No. 82-0192; or any other geographic area designated as a LATA in the National Exchange Carrier Association, Inc. Tariff F.C.C. No. 4.

Message Telecommunications Service

The furnishing of facilities for telecommunications between station lines in different local service areas.

Residential Service

Service is classified and charged for as Residential Service where the primary use of the service is of a domestic nature and where the business use, if any, is merely incidental.
