#### 4. BUNDLED SERVICES

### 4.1. GENERAL

This section contains optional bundled offerings of the Company that include regulated local exchange services along with regulated services under another tariff of the Company as well as non-regulated services such as Internet and Cable TV. Those services included in these bundles that are not covered by the Company's tariffs will be marked with the symbol "\*" where they appear in the service description and regulations in this section of the Tariff.

## 4.2. Grandfathered Integrated Offering [1]

The Integrated Offering is available to residential customers only, and is provided in conjunction with an associated long distance service provided by the Company. Customers who order the Integrated Offering must be presubscribed to the Company for both Intrastate and Interstate long distance.

The Integrated Offering is subject to monthly recurring charges and/or per minute usage, on a per access line basis. Each of the following offers provides customers with the option of one to four access lines. The customer may add one additional line per offer, up to a total of four lines per single-family account. For each local access line a customer may subscribe to one of the following options.

## 4.2. Grandfathered Integrated Offering (Cont'd) [1]

## **4.2.1.** BLOCK OF TIME OFFERS [1]

The following Block of Time plans provide the customer with unlimited calls within their Local Calling Area and a specified amount of long distance calling for a flat monthly fee. The following types of calls do not apply towards minutes included in any of the block-of-time plans listed below: Operator Assisted calls, Calling Card calls, Information Service Provider calls (i.e., 976, 900), international calls, or calls to toll free dialing numbers. Block of Time usage is measured per month, based on all applicable usage on all lines associated with the account. Unused portions of the monthly allowance will not be credited to a subscriber's account, carried over to another month, or transferred to another account. Optional features are available for an additional monthly charge, as specified in Section 3.5 of this Tariff.

## A. 180 Minute Block of Time Offer [1,2]

The 180 Minute Block of Time offer provides the customer with a local access line, touch-tone service, unlimited calls within the customer's local calling area, and 180 minutes of domestic long distance calling per monthly billing period. Additional Intrastate long distance calling will be rated on a per minute basis as specified in Comcast Interexchange Services Tariff V.S.C.C. No. 2, Section 3.

## B. 300 Minute Block of Time Offer [1,2]

The 300 Minute Block of Time offer provides the customer with a local access line, touch-tone service, unlimited calls within the customer's local calling area, and 300 minutes of domestic long distance calling per monthly billing period. Additional Intrastate long distance calling will be rated on a per minute basis as specified in Comcast Interexchange Services Tariff V.S.C.C. No. 2, Section 3.

### C. 600 Minute Block of Time Offer [1,3]

The 600 Minute Block of Time offer provides the customer with a local access line, touch-tone service, unlimited calls within the customer's local calling area, and 600 minutes of domestic long distance calling per monthly billing period. Additional intrastate long distance calling will be rated on a per minute basis as specified in Comcast Interexchange Services Tariff V.S.C.C. No. 2, Section 3.

### D. 1000 Minute Block of Time Offer [1,3]

The 1000 Minute Block of Time offer provides the customer with a local access line, touch-tone service, unlimited calls within the customer's local calling area, and 1000 minutes of domestic long distance calling per monthly billing period. Additional intrastate long distance calling will be rated on a per minute basis as specified in Comcast Interexchange Services Tariff V.S.C.C. No. 2, Section 3.

## E. "By The Minute" Offer [1,2]

The "By the Minute" offer provides the customer with a local access line, touchtone service, unlimited calls within the customer's local calling area, and intrastate long distance calling rated on a per minute basis as specified in Comcast Interexchange Services Tariff V.S.C.C. No. 2, Section 3.

## **4.2.2. ADDITIONAL LINES** [1,2]

The customer may add additional access lines, up to a total of four lines per account. A monthly charge for each additional line will be assessed.

4. Comcast Complete<sup>tm</sup> Plus [1,2]

Provides a local access line in combination with the Premium Pack optional feature package and the By-the-Minute usage component (as described in 4.2.1.E preceding).

5. Comcast Complete<sup>tm</sup> 180 [1,2]

Provides a local access line in combination with the Premium Pack optional feature package and the 180 Minute Block of Time usage component (as described in 4.2.1.A, preceding).

Provides a local access line in combination with the Premium Pack optional feature package and the 300 Minute Block of Time usage component (as described in 4.2.1.B, preceding).

- A. Package Description (Cont'd)
  - 7. Comcast Connections Any Distance<sup>tm</sup> Plan [1,2]

The Comcast Connections Any Distance plan provides the residential customer with one access line, unlimited local calling, Caller ID, Call Waiting, Call ID with Call Waiting, Call Return, LD Alert, and unlimited usage that the customer may use for local toll, intrastate, or interstate direct-dialed calling. Additional access lines and custom calling features (excluding Call Forwarding Remote Access) may be ordered by the customer on an a la carte basis at an additional charge.

To enroll in the Comcast Connections Any Distance plan, the customer must subscribe to Comcast as their primary interLATA carrier, primary intraLATA carrier, and local exchange carrier.

The Comcast Connections Any Distance plan is offered subject to the availability of existing facilities and systems. Service is limited to use by the customer, members of the customer's household, and occasional guests. The Company may monitor the customer's usage to ensure that such usage is consistent with the applicable restrictions and limitations on residential versus business service. Participation may be terminated for customers who utilize service in a manner or for a purpose other than those described herein. Due to the bulk nature of the usage, call detail is not automatically provided on the monthly billing statement. Upon customer request, such detail will be provided under separate cover.

Unused minutes are not transferable and may not be accumulated from one month to another. Such unused minutes in any month revert to the Company, and in no event shall Comcast be obligated to provide any credit or monetary sum to the customer.

## 4.5. Grandfathered Broadband Business Bundled Services [1,2]

Broadband Business Bundled Services are offered in conjunction with an associated long distance service provided by the Company. Broadband Business Bundled Services are subject to monthly recurring charges, usage rates, and, for certain call types, service charges on a per access line basis. Customers may also order optional features for an additional monthly charge as shown in Section 3.5.2, preceding.

## 4.5.1. Broadband Business Bundle [1,2]

The Broadband Business Bundle provides the customer an access line, touchtone service, one commercial white page listing, one simple yellow page listing, 900/976 call blocking, and unlimited calling within the customer's Local Calling Area, and intrastate long distance calling rated on a per minute basis as specified in Comcast Interexchange Services Tariff V.S.C.C. No. 2, Section 3.

## 4.5.2. Broadband Business Bonus Bundle [1,2]

The Broadband Business Bonus Bundle provides the customer an access line, touch-tone service, one commercial white page listing, one simple yellow page listing, 900/976 call blocking, and unlimited calling within the customer's Local Calling Area, intrastate long distance calling rated on a per minute basis as specified in Comcast Interexchange Services Tariff V.S.C.C. No. 2, Section 3, and all of the features as shown in Section 3.5.2.

## 4.5.3. OPTIONAL FEATURES [1,2]

The customer may choose to subscribe to optional custom calling features, as defined in Section 3.5.2. Monthly recurring charges associated with optional features are applied per access line, and are in addition to any other applicable charges. Customers who subscribe to two or more features will receive a discount on the monthly recurring charge, as specified in Section 3.5.2.C.2.b.

If the customer selects the Broadband Business Bundle, the offer will be automatically upgraded to the Broadband Business Bonus Bundle that includes all features in the monthly charge.
