6.1.1. DESCRIPTION OF SERVICE

Comcast Digital Phone Business Local Service provides the customer with one access line, touch-tone service, one commercial white page listing, one simple yellow page listing, 900/976 call blocking, and unlimited calling within the customer's Local Calling Area as described in Section 3.

The Company's services are furnished subject to the availability of facilities within the Local Serving Area and are subject to the terms and conditions of this Tariff.

This service is offered as a stand-alone local offer or in conjunction with an associated long distance service provided by the Company, and is subject to monthly recurring charges, usage rates, and for certain call types, service charges on a per call basis.

Optional features are available as set forth in Section 6.1.2.B, following. Monthly recurring charges associated with features are applied per access line, and are in addition to any other applicable charges.
