1.4. APPLICATION

This tariff sets forth terms and conditions applicable to all intrastate regulated telecommunications services offered by Comcast Phone of Virginia, LLC ("the Company") within the Commonwealth of Virginia. Service offerings, rates and conditions applicable to specific service offerings are set forth in other tariffs of the Company and are in addition to the general regulations contained herein.

All offered service contained herein is subject to available facilities and necessary governmental authorization in the jurisdiction where the service is offered.

To the extent that the Company does not have access to facilities to serve portions of the Commonwealth of Virginia, the Company may serve residents and businesses in those areas by means of the resale of services of other service providers.

Broadband Service

Broadband Service may provide both Broadband Local Service and intrastate long distance calling provided in conjunction with Broadband Local Service.

Broadband Local Service

Broadband Local Service provides the customer with an access line and usage within a Local Calling Area for the transmission of two-way interactive switched voice or data communications.

Business Service

Service is classified and charged for as Business Service where the primary use of the service is of a business, professional, or occupational nature, or where a business directory listing is furnished.

Communications Services

The Company's intrastate regulated telecommunications services.

Company

Comcast Phone of Virginia, LLC

Customer

The person, firm or corporation which purchases service and is responsible for the payment of charges and compliance with the Company's regulations.

Customer Premises

The customer premises is all space in the same building occupied by a customer and all space occupied by the same customer in different buildings on contiguous property.

<u>LATA</u>

A Local Access and Transport Area established pursuant to the Modification of Final Judgment entered by the United States District Court for the District of Columbia in Civil Action No. 82-0192; or any other geographic area designated as a LATA in the National Exchange Carrier Association, Inc. Tariff F.C.C. No. 4.

Local Calling Area

The area in which a customer may complete calls without incurring long distance charges.

Local Exchange Service

The provision of an access line and usage within a Local Calling Area for the transmission of high quality interactive switched voice or data communication.

Local Serving Area

The area in which the Company has the capability to provide Local Service.

Monthly Rate

The monthly rates to the customer for services, facilities and equipment, which continue for the agreed upon duration of the service.

Residential Service

Service is classified and charged for as Residential Service where the primary use of the service is of a domestic nature and where the business use, if any, is merely incidental.
