TARIFF FORMAT

A. PAGE NUMBERING

Page numbers appear in the upper right corner of the page. Pages are numbered sequentially. However, new pages are occasionally added to the tariff. When a new page is added between pages already in effect, a decimal is added. For example, a new page added between Page 14 and 15 would be 14.1.

B. PAGE REVISION NUMBERS

Revision numbers also appear in the upper right corner of each page. These numbers are used to determine the most current page version on file with the Commission. For example, the 4th revised Page 14 cancels the 3rd revised Page 14.

C. PARAGRAPH NUMBERING SEQUENCE

There are various levels of paragraph coding. Each level of coding is subservient to its next higher level:

D. CHECK SHEETS

When a tariff filing is made with the Commission, an updated Check Sheet accompanies the tariff filing. 1.4. **DEFINITIONS**

Access Line

An arrangement which connects the customer's location to the Company's designated point of presence or network switching center.

Account

The customer who has agreed, verbally or by signature, to honor the terms of service established by the Company. An account may have more than one access line billed to the same customer address.

Authorized User

A person, firm or corporation, or any other entity authorized by the customer to communicate utilizing the Company's services.

"Commission" or "PSC"

The Maryland Public Service Commission.

Company

Whenever used in this tariff, "Company", or "Comcast" refers to Comcast Phone of Northern Maryland, Inc., unless otherwise specified.

Completed Call

A call which the Company's network has determined has been answered by a person, answering machine, fax machine, computer modem device, or other answering device.

1.4. **DEFINITIONS (CONT'D)**

Customer

The person, firm, corporation or governmental unit which orders Service and which is responsible for the payment of charges and for compliance with the Company's tariff regulations. A Customer is considered to be an account for billing purposes. The term Customer also includes an entity that remains presubscribed to the Company Service after its account(s) are removed from the Company's billing system, subsequently continues to use Company's network, and is billed by a local exchange carrier for such use, or otherwise uses Service for which no other Customer is obligated to compensate the Company.

Customer Premises

The customer premises is all space in the same building occupied by a customer and all space occupied by the same customer in different buildings on contiguous property.

Facilities

Supplemental equipment, apparatus, wiring, cables and other materials and mechanisms necessary to or furnished in connection with communications service.

Service

Any business telecommunications service(s) provided by the Company under this tariff.

Service Area

The area in which the Company has the capability to provide local telephone service.

Station

A telephone instrument consisting of a connected transmitter, receiver, and associated apparatus to permit sending or receiving telephone messages.

User

A customer, or any other person authorized by a customer, to use service provided under this tariff.
