## **Description**

This schedule specifies the rates that apply to direct-dialed international long distance calling available to business trunk subscribers of Comcast's Business Voice service offerings. Limited International Service allows the Customer to limit country availability for the completion of direct-dialed international calls. Calls to countries excluded from Limited International Service may be completed on an operator-assisted basis. Business trunk subscribers wishing to expand the list of available country destinations may select Expanded International Service.

## **Terms and Conditions**

"You" and "Your" mean current customers, visitors, guests and any other authorized user (or users reasonably assumed to be authorized) of the customer's Business Voice service.

"Company" means Comcast and any subsidiaries or affiliates providing service under this Service Guide.

Limited International Service is offered subject to the following conditions:

The rates included in this schedule are limited to direct-dialed station-to-station international calls that are made from your business billed to your business account, and made without using an operator or an automated call processing system. (Calls requiring the assistance of an operator are subject to additional charges.)

The usage rates shown are per-minute, per country, 24 hours a day, seven days a week. The duration of each call is recorded in whole minutes, with partial minutes rounded up to the next whole minute (for example, a 45-second call will be billed as a one-minute call).

Calls placed to mobile (cellular) subscribers are subject to the rates listed under the heading "Mobile Rate Per Minute".

Service is offered subject to the continuing availability of billing and technical resources.

Local, State and/or Federal taxes may apply. In addition, the Company reserves the right to pass-on taxes or fees imposed on the Company by any appropriately authorized entity.
